The Association shall have final jurisdiction in any question of location of any service line connection to its distribution system; shall determine the allocation of water to Renter in the event of a water shortage; may shut off the water to Renter who allows a connection or extension to be made to his service line for the purpose of supplying water to another user.

The failure of a Renter to pay water charges duly imposed shall result in the automatic imposition of the following: penalties:

- A. Non-payment within ten (10) days from the bill date will be subject to a penalty of ten (10) percent of the delinquent account.
- B. Non-payment within thirty (30) days from the bill date will result in the water being shut off from the Renters property.
- C. Non-payment for sixty (60) days after original bill date will allow the Association to terminate the Rental agreement and, in such event, the Renter shall not be entitled to receive, nor the Association obligated to supply, any water under this Agreement.

In the event it becomes necessary for the Association to shut off the water at said Rental property, a fee of **\$60.00** will be charged for a reconnection of the service.

The above signed (hereafter called the applicant) requests service with and agrees to purchase water from the Collinsville Water Association as measured by the Association's meters according to rates applicable. Rental fee is non-refundable and is not transferable from one location to another. If upon discontinuance of service applicant is indebted to the Association, the applicant will not be eligible for re-application for new service until the final bill is paid in full. Any additional balance may be charged to any of the applicant's other water accounts or payment required in full before service reconnection in another location.

\*\*Sewer rates are Residential \$1.00 / Commercial \$3.00 per thousand gallons after the minimum.
